- □ I have read and understood the processing fees incurred for the Malaysia visa Process, Any other additional fee/costs incurred and not mentioned in the additional fees/costs incurred and not mentioned in the **"Student Pass and Health Examination Information Packet"** will be borne by myself.
- I understand that after receiving my eVAL (Electronic Visa Approval Letter), I may be required to apply for a Single Entry Visa (if applicable) from the Malaysian Embassy/High Commissions/Consulate in my country of residence. Or apply eVISA thru online via: <u>https://malaysiavisa.imi.gov.my/evisa/evisa.jsp</u>
- □ I understand that due to the new Ministry of Higher Education and Malaysian Immigration Department ruling, I will only be able to enter Malaysia and register with the University after completing the above-mentioned visa processes.
- □ I understand that I can only enter Malaysia after receiving my eVAL (and Single Entry Visa (SEV), if applicable).
- □ I understand that eVAL is processed by EMGS and issued by the Immigration Department of Malaysia and not by the University.
- □ I understand that the University has limited control over the visa processing duration and will not be held responsible for delays at both EMGS and Immigration Department.
- □ I understand, if I am holding Conditional offer letter and eVAL is approved, I shall not apply for SEV (if applicable) and enter Malaysia without obtaining my Unconditional offer being issued by the Admission Office.
- □ I understand, I will be responsible for any decision taken by EMGS and Immigration Department if fail to meet any entry requirements for the applied course. This including going back to my country or country of residence.
- I understand, I will not claim any costs incur from the university if I am required to leave the country for the above reasons.
- □ I am aware I will not make any travel plans once arrive with VAL and till passport is returned back from EMGS with Student Pas endorsement.
- □ I understand that I will shorten/cancel my student pass once completed/graduated my studies as per the directives by the Ministry of Higher Education and Immigration Department. This including if I were to defer/withdraw/termination of studies after student pass is issued to me.
- □ I will provide my flight ticket to home country or country of residence, passport and payment for shorten/cancellation one month prior my flight date as the processing timeline is minimum 14 working days from the day passport is submitted to EMGS/Immigration.
- □ I understand that I will report and follow instructions given by Visa Office if I were to change my course during my studies and re-apply for new eVAL as per Ministry's ruling.
- □ I understand how to contact the Visa Office in case of needing additional assistance.
