



Nottingham-World Bank Asian Economics Essay Competition 2024 Terms and Conditions

- 1. The topic of the essay competition is: "Discuss the role of the government in the green transition. Suggest a policy agenda that can help accelerate the evolution to a sustainable, net-zero future. Your answer might include fiscal and monetary policies for green transition as well as macro and regulation policies."
- 2. The competition is open to all pre-university (including A level, STPM, UEC, SPM, international schools, foundations and other pre-university programmes) and high school programmes in Asia. Submission can be from a single author or joint authored by a maximum of two authors.
- 3. The following prizes will be awarded:

First prize	:	RM 1,000.00
Second prize	:	RM 800.00
Third prize	:	RM 600.00
3 consolation prizes	:	RM 350.00 each

- 4. The winning essays will be selected by a panel of judges from the Nottingham School of Economics Malaysia and the World Bank Group Inclusive Growth and Sustainable Finance Hub in Malaysia. The decision on the winning essays by panel of judges is final and no appeal will be accepted.
- 5. The essays will be judged according to the following criteria:
 - i) Originality / creativity of ideas
 - ii) Structure and presentation of the essay
 - iii) Depth of analysis and arguments
- 6. Only one entry per student is permitted.
- 7. Entries to the competition must be unique (i.e., not published elsewhere or submitted to other essay competition) and original in content. Entries found to contain plagiarism will be disqualified. A bibliography acknowledging references to existing work is required.
- 8. The essays should be accessible to a wide audience. They are not meant to be academic journal-style papers.
- 9. The essays may include charts and tables; equations should be avoided as far as possible.

- 10. Entries must be in English. The word count should be between 1500 to 2000 words (excluding charts, tables, and references, but including footnotes). Essays with less than 1500 words will be automatically disqualified to discourage frivolous entries.
- 11. To participate in the competition, fill up the participation form at <u>https://forms.office.com/r/xHfpYJeJwi</u> and follow the instructions there to submit the essay. The deadline for submission is 22 July 2024, 11:59pm Malaysia time.
- 12. For joint authorship, key in the names and info of both authors in the same boxes in the participation form, separated by appropriate punctuation marks or spacing.
- 13. To make sure that judging can be anonymous, please do not write your name or your school anywhere in the essay itself.
- 14. The essay must be submitted as a single **pdf file** of less than 20MB in size to the link mentioned in the participation form. The file must be named in the following format "[first letter of your name]_[last letter of your name]_[8 numerical numbers of your choice].pdf". For example, if your name is Keynes Hayek, your file name can be K_K_13146688.pdf. For jointly authored essays, use only the first author's first letter and last letter of name.
- 15. Entries that do not adhere to points 13 and 14 above will be automatically disqualified.
- 16. The results will be announced latest in the final quarter of 2024. The organiser reserves the right not to award any or all of the prizes and shall own the copyright to the entries. Only prize winners will be contacted by the organizer.
- 17. Close family members (defined as children) of employees in the School of Economics, University of Nottingham Malaysia and the World Bank Group Inclusive Growth and Sustainable Finance Hub in Malaysia are not eligible to participate in the essay competition.
